Volunteer and Confidentiality Agreement and Liability Release Waiver

Volunteer Agreement

While volunteering with KittyMamas Sanctuary Rescue ("KMSR"), I agree to the following terms and conditions intending to be legally bonding to them:

- I will abide by the mission, rules, regulations, policies and programs of KMSR while I am a volunteer.
- I will not engage in any unsafe, illegal, or unethical activities while acting as a KMSR volunteer.
- I understand that when I represent KMSR in my dealings with the public, I will remain professional.
- I understand this is a volunteer position, and I will not receive any compensation or benefits for the service I provide to KMSR or any of the fosters who are fostering cats.
- I am volunteering at will, meaning that I may end my volunteering with KMSR for any reason at any time with or without notice and I understand that KMSR may end my volunteer work at any time for any reason, with or without notice.
- I will not intentionally harm the cats.
- I have not been threatened or coerced into volunteering for KMSR.

Confidentiality Agreement

During the course of me volunteering with KMSR, I may become privy to confidential information concerning the management and operations of KMSR, its fosters, adopters, volunteers, board members and donors that is generally not known to the public and should be kept confidential. The following guidelines have been developed for this purpose.

- Confidential information should only be shared with those inside the organization whose jobs require them to have access to the information or when the law requires or protects the release of such information.
- Volunteers should not disclose sensitive or non-public information to people outside the organization or discuss it in public places.
- Documents containing sensitive information, including information stored on computer systems, should be handled carefully and must be properly stored.

Liability Release Waiver

During the course of me volunteering with KMSR, I recognize that while performing my services in a voluntary capacity in handling animals or performing other duties, there may be a risk of injury.

- On behalf of myself, my heirs, and personal representatives, I hereby release and hold harmless KMSR, its Board of Directors, agents, fosters and other volunteers from any and all claims, causes of action or demands of any nature or cause connected to my volunteer service.
- I also agree to release and hold KMSR and their fosters harmless for any and all damages to my personal property while performing my volunteer services.
- I acknowledge that I have read and fully understand the terms and conditions of the foregoing liability release waiver.

I understand this is a volunteer position, and I will not receive any compensation or benefits for the service I provided to KMSR or any of the fosters who are fostering cats. I am volunteering at will, meaning that I may end my volunteering with KMSR for any reason at any time with or without notice and I understand that KMSR may end my volunteer work at any time for any reason, with or without notice.

As a condition of volunteering, which I acknowledge to be adequate consideration, I have read, understand and agree to abide by the terms outlined in the Volunteer Agreement, the Confidentiality Agreement and the Limited Liability Release Waiver. I understand that failing to uphold terms outlined in the Volunteer Agreement, the Confidentiality Agreement and the Limited Liability Release Waiver is sufficient grounds for KMSR to request and implement my removal as a volunteer.
